RENTAL SCHEME - TERMS AND CONDITIONS

1. During the rental period the instrument remains the property of Myatt Music Ltd. and maintenance is free unless required due to careless mishandling or accident. Repairs to instruments returned damaged will be charged to your card after notification has been sent.
2. It is your responsibility to return the instrument to the shop at your own cost. The instrument MUST reach the shop BEFORE the renewal date, otherwise a further rental will be charged for. You must ensure that if the instrument is to be returned it is carefully packed and fully insured, as if it is damaged in transit you will be responsible.
3. This is NOT a hire purchase agreement. Only the first rental payment may be deducted from the discount price of the instrument and only if previous payments have been made on time. After the first term the balance to purchase price remains the same.
4. After 10 terms rental the instrument becomes your property assuming these conditions have been met.
5. A term is taken as 4 months from the 1st of the next month.
6. The rental prices listed here are for basic student instruments.
7. It is your responsibility to inform us of any change to the details given here.
8. This instrument is not insured, we strongly recommend that you take out insurance for it, as loss or damage will be charged.
